7) Old Business

Part 1325

The Statewide 9-1-1 Administrator, Alicia Atkinson, went through the edits that were made on Part 1325 with the Board members. Board members provided comments and questions to the edits.

- The Chairman allowed comments from the Board and public comment on Part 1325. Discussions were held on topics concerning definition changes, corrections, reviewing the rules more often, concern for ETSBs that don't have direct authority over the people that work in their PSAPs and the challenges that come forward with these rules, The Statewide 9-1-1 legal counsel, Elizabeth Lepic, provided legal guidance on the questions about county employees and elected officials and the requirements of these rules and possible new language to address this issue, concerns about the Sheriff's Association still not having a representative on the Board, comments about cybersecurity information were discussed,
- O Jim Kaitschuk stated in the chat that this isn't necessarily a sheriff decision, the county board sets his budget, and many employees serve dual positions. They may have a correctional officer who is also a telecommunicator.

- Doug Clark, Perry County, stated that it's important to remember that these sheriff's or
 police departments are not required to take calls. So they could also be compelled to
 end the agreement and leave a system hanging on who's going to take their calls if they
 no longer want to fill that role.
- Aaron Weber, Madison County, stated that he would like to have another meeting with his board representatives prior to a vote being taken on Part 1325 to discuss some concerns.
- O Heather Butler, Dekalb County, had a question about Part 1325, section 330, concerning call volumes and reporting that number on the AFR. She stated that now that NGCS providers are also reporting call volumes, what will happen if there's a discrepancy and the numbers do not match. The Statewide 9-1-1 Administrator stated that it would have to be looked into if there is a discrepancy, but she doesn't think it would be a significant issue. Cindy Barbera-Brelle also stated that ISP receives call statistics from each of the providers.
- The Chairman stated that the Board will be taking a vote for consensus to move Part 1325 to JCAR once edits mentioned today have been made. The Chairman stated that Board members can still make suggestions, if needed.
- With a motion to approve by John Ferraro, with edits discussed today, and a second by Sam McClerren, with edits discussed today, the motion was unanimously approved by the Board.
