ORDER OF THE STATEWIDE 9-1-1 ADMINISTRATOR

WHEREAS, the Calumet Park Regional 911 Authority (CalComm) submitted a modification plan with the Office of the Statewide 9-1-1 Administrator on April 11, 2023, seeking to opt out the Village of Robbins;

WHEREAS the modification plan has been read and reviewed by the Department and the Administrator; and

WHEREAS the modification plan seeks to opt out the Village of Robbins into the Cook County ETSB;

WHEREAS as it relates to "wireless" surcharge monies, Section 30(b)(1)(D) and 30(2)(E) of the ETSA directs the Department to make monthly grants to the appropriate 9-1-1 Authority currently taking wireless 9-1-1 based upon zip code billing of wireless subscribers. Accordingly, the IGA specified the boundary change resulting from Robbins disengaging with CalComm and consolidating with Cook County and specified that Cook County will then be responsible to account for such monies in its audited annual financial reporting as required under Section 40 of the ETSA.

WHEREAS Cook County and CalComm have entered into an IGA concerning the payment of 9-1-1 surcharge, the financial reporting and auditing of the funds, and other specifics concerning the addition of Robbins to the Cook County ETSB.

NOW THEREFORE, the Administrator orders the following;

IT IS HEREBY ORDERED that the CalComm Regional Joint ETSB's request for approval of its modification plan as follows:

Opting out the Village of Robbins from the CalComm Regional 9-1-1 System To the Cook County 9-1-1 System.

pursuant to Title 83: Public Utilities Chapter IV: Department of State Police Part 1325 - Standards of Service Applicable to 9-1-1 Emergency Systems Section 205, is hereby approved subject to the requirements of this Order.

IT IS FURTHER ORDERED that the CalComm modification will be completed no later than June 30, 2023.

IT IS FURTHER ORDERED that the Calumet Park Regional 911 System will file with the Administrator a Wireless 9-1-1 Plan that removes Robbins from their current Plan with an effective date no later than June 30, 2023.

IT IS FURTHER ORDERED that the Robbins surcharge payments currently being distributed to the Calumet Park Regional 911 System shall begin to be distributed to the Cook County ETSB as defined in 50 ILCS 750/30 beginning with the July 2023 remit period.

This Order is a final administrative decision of the Statewide 9-1-1 Administrator subject to review under the Administrative Review Law, 735 ILCS 5/3-101. In the event you wish to seek review of or appeal this Order, you are advised:

- 1. Every action seeking review of such final decision shall be commenced by the filing of a Complaint and the issuance of Summons in the Circuit Court within 35 days from the date a copy of the decision was served upon the parties.
- 2. In your action seeking review you must name in the Complaint, and issue a Summons for each party of record to the case other than yourself.
- 3. Attached below is a list of all parties of record to this case, including the name and address of the agency or officer entering the Order, and the addresses of each party where the parties may be served with pleadings, notices, or service of process for any review or further proceedings.
- 4. You are not required to file any motion or request for reconsideration with the Department or the Statewide 9-1-1 Administrator before filing your action for review in the Circuit Court. The administrative rules of the Department do not require or allow for any further proceedings before the Statewide 9-1-1 Administrator.
