Application for 9-1-1 Modification Plan

ORDER OF THE STATEWIDE 9-1-1 ADMINISTRATOR

WHEREAS, the Consolidated Emergency Response Center of Cook County (CERCCC) submitted a modification plan with the Office of the Statewide 9-1-1 Administrator on December 6, 2022, seeking to opt in the Village of Forest View;

WHEREAS the modification plan has been read and reviewed by the Department and the Administrator; and

WHEREAS the modification plan seeks to opt in the Village of Forest View into the Consolidated Emergency Response Center of Cook County (CERCCC) 911 System;

WHEREAS as it relates to "wireless" surcharge monies, Section 30(b)(1)(D) and 30(2)(E) of the ETSA directs the Department to make monthly grants to the appropriate 9-1-1 Authority currently taking wireless 9-1-1 based upon zip code billing of wireless subscribers. Accordingly, the IGA specified the boundary change resulting from Forest View disengaging with South West Cook County and consolidating with CERCCC and specified that CERCCC will then be responsible to account for such monies in its audited annual financial reporting as required under Section 40 of the ETSA.

WHEREAS South West Cook County and CERCCC have entered into an IGA concerning the payment of 9-1-1 surcharge, the financial reporting and auditing of the funds, and other specifics concerning the addition of Forest View to CERCCC.

On December 19, 2022, Catherine Dailey, 911 Analyst, Statewide 9-1-1 Bureau filed a Technical Review to the Application. The Technical Review met the requirements of 83 Illinois Administrative Code Part 1325.

NOW THEREFORE, the Administrator orders the following;

IT IS HEREBY ORDERED that the Consolidated Emergency Response Center of Cook County's request for approval of its modification plan as follows:

Opting in the Village of Forest View from the South West Cook County Consolidated 9-1-1 System to the CERCCC 9-1-1 System

pursuant to Title 83: Public Utilities Chapter IV: Department of State Police Part 1325 - Standards of Service Applicable to 9-1-1 Emergency Systems Section 205, is hereby approved subject to the requirements of this Order.

IT IS FURTHER ORDERED that the Forest View modification will be completed no later than December 31, 2022.

IT IS FURTHER ORDERED that CERCCC's 9-1-1 System Service Provider will conduct a P.01 Study and if necessary, a Traffic Study to determine the number of 9-1-1 trunks required to serve the CERCCC with the addition of Forest View.

IT IS FURTHER ORDERED that CERCCC will file with the Administrator a Wireless 9-1-1 Plan along with an updated Zip Code Agreement that adds Forest View to their current Plan with an effective date no later than December 31, 2022.

IT IS FURTHER ORDERED that the Forest View surcharge payments currently being distributed to the South West Cook County Consolidated 9-1-1 System shall begin to be distributed to the CERCCC 9-1-1 System as defined in 50 ILCS 750/30 beginning with the January 2023 remit period.

IT IS FURTHER ORDERED that CERCCC is responsible for the accounting and audited annual financial reporting for Forest View wireless surcharge monies.

This Order is a final administrative decision of the Statewide 9-1-1 Administrator subject to review under the Administrative Review Law, 735 ILCS 5/3-101. In the event you wish to seek review of or appeal this Order, you are advised:

- 1. Every action seeking review of such final decision shall be commenced by the filing of a Complaint and the issuance of Summons in the Circuit Court within 35 days from the date a copy of the decision was served upon the parties.
- 2. In your action seeking review you must name in the Complaint, and issue a Summons for, each party of record to the case other than yourself.
- 3. Attached below is a list of all parties of record to this case, including the name and address of the agency or officer entering the Order, and the addresses of each party where the parties may be served with pleadings, notices, or service of process for any review or further proceedings.
- 4. You are not required to file any motion or request for reconsideration with the Department or the Statewide 9-1-1 Administrator before filing your action for review in the Circuit Court. The administrative rules of the Department do not require or allow for any further proceedings before the Statewide 9-1-1 Administrator.
