### INTRODUCTION

This Executive Summary of the *Crime in Illinois 2005*, Annual Uniform Crime Report, is intended to provide readers with a high-level overview of the nature of crime in Illinois. This summary highlights statewide statistics and topics of interest. Detailed statistics and analyses are contained in the complete *Crime in Illinois 2005*, Annual Uniform Crime Report, which is available via the internet through the Illinois State Police website at http://www.isp.state.il.us.

During 2005, 966 agencies submitted data directly to the Illinois Uniform Crime Reporting (I-UCR) Program. The remaining agencies reported their crime statistics through an intermediary agency (sheriff's office, police department, etc.). A complete listing of agencies that participated and their respective extent of participation is available in the complete publication.

Local law enforcement agencies are mandated by Chapter 20 of the Illinois Compiled Statutes, 2630/8, to report crime index offenses, crime index offense arrests, and drug arrests. The 2004 figures may not reflect the figures published in *Crime in Illinois 2004* due to submission of late and/or adjusted data.

### **SUMMARY OF CRIME IN ILLINOIS**

Crime index offenses are considered to be the most serious and the most likely to be reported, and are used nationally as the standard base for comparisons. The I-UCR crime index offenses and crime index offense arrests include the categories of murder, criminal sexual assault, robbery, aggravated assault/battery (including attempted murder and ritual mutilation), burglary, theft (including burglary from a motor vehicle), motor vehicle theft, and arson.


#### Summary

There were 473,834 crime index offenses reported to the I-UCR Program this year, an average of 1,298 each day, or one every 67 seconds. This is a 2.6 percent decrease from the 486,469 crime index offenses reported last year. The crime index offense rate for 2005 is 3,727.0 per 100,000 inhabitants.

#### **Arrests**

There were 103,049 arrests in 2005 for crime index offenses. This is a 1.5 percent decrease from the 104,607 arrests reported in 2004. The crime index offense arrest rate for 2005 is 810.5 per 100,000 inhabitants.






### **Summary**

There were 72,227 violent crime offenses reported to the I-UCR Program this year, an average of 197 each day, or one every 7 minutes and 17 seconds. This is a 1.5 percent increase from the 71,142 violent crime index offenses reported last year. The violent crime offense rate for 2005 is 568.1 per 100,000 inhabitants.

#### **Arrests**

There were 26,939 arrests this year for violent crime offenses. This is a 3.8 percent increase from the 25,962 arrests reported last year. The violent crime offense arrest rate for 2005 is 211.9 per 100,000 inhabitants.

# **PROPERTY CRIME**



**Definition:** The crime index offenses of burglary, theft (including burglary from a motor vehicle), motor vehicle theft, and arson comprise the general category of property crime.

### **Summary**

There were 401,607 property crime offenses reported to the I-UCR Program this year, an average of 1,100 each day, or one every 1 minute and 9 seconds. This is a 3.3 percent decrease from the 415,327 crime index offenses reported last year. The property crime index offense rate for 2005 is 3,158.9 per 100,000 inhabitants.

#### **Arrests**

There were 76,110 arrests this year for property crime offenses. This is a 3.2 percent decrease from the 78,645 arrests reported last year. The property crime index offense rate for 2005 is 598.6 per 100,000 inhabitants.

### **CORE BASED STATISTICAL AREAS**

The United States Office of Management and Budget developed new standards to define Core Based Statistical Areas (CBSAs) beginning in 2003. These standards replace and supersede the 1990 standards for defining Metropolitan Statistical Areas.

CBSAs are defined as a statistical geographic entity consisting of the county or counties associated with at least one core (urbanized area or urban cluster) of at least 10,000 population, plus adjacent counties having a high degree of social and economic integration with the core as measured through commuting ties with the counties containing the core. The new standards designate and define two categories of CBSAs: Metropolitan Statistical Areas and Micropolitan Statistical Areas. These are the terms used for the basic set of county-based areas as defined under this classification.

Metropolitan Statistical Areas have at least one urbanized area of 50,000 or more population, plus adjacent territory that has a high degree of social and economic integration with the core as measured by commuting ties. Micropolitan Statistical Areas—a new set of statistical areas—have at least one urban cluster of at least 10,000 but less than 50,000 population, plus adjacent territory that has a high degree of social and economic integration with the core as measured by commuting ties. If the specified criteria are met, a Metropolitan Statistical Area containing a single core with a population of 2.5 million or more may be subdivided to form smaller groupings of counties referred to as Metropolitan Divisions. Counties that do not fall within CBSAs represent Outside Core Based Statistical Areas.

There are 11 Metropolitan Statistical Areas that include 36 counties in Illinois. Inhabitants of the Metropolitan Statistical Areas account for 86.7 percent of the state's population and 90.5 percent of the Illinois crime index offenses. There are 23 Micropolitan Statistical Areas that include 29 counties in Illinois. Inhabitants of the Micropolitan Statistical Areas account for 8.4 percent of the state's population and 7.0 percent of the Illinois crime index offenses. There are 37 counties that comprise the Outside Core Based Statistical Areas in Illinois. Inhabitants of the Outside Core Based Statistical Areas account for 4.9 percent of the state's population and 2.5 percent of the Illinois crime index offenses. In some cases the percentages may not sum to 100 due to rounding.

Six of Illinois' Metropolitan and Micropolitan Statistical Areas are part of areas in Indiana, Iowa, Kentucky, Missouri, and Wisconsin. Areas outside of Illinois are not represented in the statistics presented here.

In April 1996, the I-UCR Program began collecting additional crime information. This data includes statistics pertaining to offenses mandated by state statutes and offenses concerning children. Due to limitations of agencies' reporting systems, all agencies are not included in the totals presented in the following tables. In some cases, the percentages may not sum to 100 due to rounding.

#### **DOMESTIC CRIMES**

Reporting domestic violence is mandated by Chapter 20 of the Illinois Compiled Statutes, 2630/5.1. Domestic-related crimes are defined as crimes committed by family or household members, including spouses, former spouses, parents, children, stepchildren and other persons related by blood or marriage, persons who share or formerly shared a common dwelling, and persons who have or allegedly have a child in common. In the case of a high-risk adult with disabilities, family or household member includes any person who has the responsibility for that individual as a result of a family relationship, or who has assumed responsibility for all or a portion of the care voluntarily, by express or implied contract, or court order.

### **Summary**

There were 115,282 domestic violence offenses reported to the I-UCR Program this year, an average of 315 each day, or one every 4 minutes and 33 seconds. This is a 6.1 percent decrease from the 122,797 domestic violence offenses reported last year. The domestic violence offense rate is 906.8 per 100,000 inhabitants.

#### **CRIMES AGAINST CHILDREN**

Although reporting in this category is not mandated by state statutes, information is collected to research and evaluate the problems of offenses against children. Contributing agencies are not required to report this data to the I-UCR Program. All crimes reported by participating agencies that involve victims aged 16 years and younger are included in this category.

### **Summary**

There were 39,400 crimes against children reported to the I-UCR Program this year, an average of 107 each day, or one every 13 minutes and 20 seconds. This is a 1.7 percent decrease from the 40,072 crimes reported last year. The crimes against children offense rate is 309.9 per 100,000 inhabitants.

#### **CRIMES AGAINST SCHOOL PERSONNEL**

The reporting of attacks on school personnel is mandated by Chapter 105 of the Illinois Compiled Statutes, 5/10-21.7. The I-UCR Program collects information relating to all crimes committed against teachers, administrative personnel, or educational support personnel. This includes teacher's aides, bus drivers, or janitors, etc., who are employed by the school.

#### **Summary**


There were 3,242 crimes against school personnel reported to the I-UCR Program this year, an average of eight each day, or one every 2 hours and 42 minutes. This is a 11.8 percent increase from the 2,900 crimes reported last year. The crimes against school personnel offense rate is 25.5 per 100,000 inhabitants.



#### **HATE CRIME**

The reporting of hate crime information is mandated by Chapter 20 of the Illinois Compiled Statutes, 2605/390(a). A hate crime is committed when, by reason of the actual or perceived race, color, creed, religion, ancestry, gender, sexual orientation, physical or mental stability, or national origin of another individual or group of individuals, a person commits assault, battery, aggravated assault, misdemeanor theft, criminal trespass to residence, misdemeanor criminal damage to property, criminal trespass to vehicle, criminal trespass to real property, mob action, or disorderly conduct.

### **Summary**

This year, 229 incidents of hate crime were reported through the I-UCR Program. These incidents were committed by 274 offenders. This is a 3.0 percent decrease from the 236 incidents reported last year. Multiple victims and/or offenses may be reported within a single incident. The following table depicts hate crime data by victim, offender race, and bias motivation.

### **Statewide**

The statewide total number of law enforcement personnel in Illinois for 2005 is 58,936. The 41,678 part- and full-time sworn officers in 2005 account for 70.7 percent of the entire state of Illinois' law enforcement work force. The 2005 rate of sworn employees to population for Illinois is 3.3 per 1,000 inhabitants. The 15,028 civilian employees comprise 25.5 percent of the entire state of Illinois law enforcement community's work force, with an employment rate of 1.2 per 1,000 inhabitants. The 2,230 auxiliary officers (officers not on active duty but subject to call in an emergency situation) in 2005 account for 3.8 percent of the entire state of Illinois law enforcement community's work force, with an employment rate of 0.2 per 1,000 inhabitants.

### **Police Departments**

Police departments employed 37,563 law enforcement employees statewide in 2005 accounting for 63.7 percent of the state law enforcement employee total. Part- and full-time sworn officers account for 82.3 percent (30,921) of the police department work force. The 2005 employment rate for sworn employees of police departments is 2.9 per 1,000 inhabitants. The 5,179 civilian employees comprise 13.8 percent of the police department work force, with an employment rate of 0.5 per 1,000 inhabitants. The 1,463 auxiliary officers in 2005 comprise 3.9 percent of the police department work force, with an employment rate of 0.1 per 1,000 inhabitants.

#### **Sheriff's Offices**

Sheriff's offices employed 14,605 law enforcement employees statewide in 2005 accounting for 24.8 percent of the state law enforcement employee total. The 6,119 part- and full-time sworn officers in 2005 account for 41.9 percent of the sheriff's offices work force. The 2005 employment rate for sworn employees of sheriff's offices is 2.9 per 1,000 inhabitants. The 7,769 civilian employees comprise 53.2 percent of the sheriff's offices work force, with an employment rate of 3.7 per 1,000 inhabitants. The 717 auxiliary officers in 2005 comprise 4.9 percent of the sheriff's offices work force, with an employment rate of 0.3 per 1,000 inhabitants.

### **Miscellaneous Agencies**

Miscellaneous agencies employed 6,768 law enforcement employees statewide in 2005 accounting for 11.5 percent of the state law enforcement employee total. Miscellaneous agencies reported 4,638 part- and full-time sworn officers in 2005 accounting for 68.5 percent of the miscellaneous agencies work force. These agencies include airports, colleges and universities, fire departments/ arson investigations, forest preserves, hospitals, other agencies, park districts, and railroads. Since miscellaneous agencies do not have a population, employment rates cannot be calculated. The 2,080 civilian employees comprise 30.7 percent of the miscellaneous agencies work force. The 50 auxiliary officers in 2005 comprise 0.7 percent of the miscellaneous agencies work force.
