

LAW ENFORCEMENT OFFICERS KILLED

During 2007, two Illinois law enforcement officers lost their lives in the performance of their duties while upholding the laws of the state of Illinois. A brief narrative of the circumstances surrounding their deaths is presented below.

July 17, 2007 - DOUGLAS COUNTY SHERIFF'S DEPARTMENT

Chief Deputy Tommy Martin, 59, succumbed to gunshot wounds sustained one month earlier on June 21, 2007, while investigating a reported home invasion. Chief Deputy Martin was conducting a canvass of the area when he observed the suspect vehicles approaching from the opposite direction. The driver of one of the suspect vehicles opened fire on Martin as the vehicles passed one another, wounding him in the face and torso. Chief Deputy Martin served in law enforcement for 29 years.

October 28, 2007 - ILLINOIS STATE POLICE

Trooper Brian McMillen, 24, died as the result of injuries sustained in a traffic accident. Trooper McMillen was responding to a request for assistance from a local law enforcement agency officer at the scene of a bar altercation when his vehicle was involved in a multi-vehicle collision. The drivers of the two additional vehicles were both intoxicated and face charges including aggravated driving under the influence of alcohol. Trooper McMillen served with the Illinois State Police for eight months.
