Repeat attenders are encouraged as critical revisions to Index Crimes, Hate Crime, Supplemental reporting, as well as detailed instruction on the new School Incidents reporting element effective with the 2014 reporting year, will be presented. Agencies are limited to sending two personnel to each training session to maximize the number of agencies that can participate at each location. All training sessions will begin at 9:00 a.m. and conclude at 3:30 p.m. There is no cost for the training.
