Master Sergeant Sean Veryzer and his canine partner Roman have exemplified exceptional dedication to duty and together have formed an extraordinary partnership. Canine Roman completed the 10-week basic canine training course and began his career in the Spring of 2013 in Troop 2. He quickly became an integral part of the northern Highway Interdiction Team. Canine Roman started his career as a full-service canine, proficient in narcotic odor detection, tracking, article searches, and criminal apprehension.



Master Sergeant Veryzer and Roman engaged with the community through demonstrations at schools and civic events, showcasing the capabilities of a well-trained K9 unit. Their efforts extended to drug searches, school searches, and building searches, impacting multiple facets of public safety.

Master Sergeant Veryzer and Roman worked collaboratively

with numerous state, county, local, and federal agencies. They focused on attacking the vulnerabilities of drug networks through coordinated interdiction efforts at all points along their transportation routes in Illinois. They have maximized the disruptive impact on individuals and criminal organizations trafficking illicit narcotics and currency through our state. Canine Roman's career highlights include:

- Assisting in the seizure of approximately 11,820 pounds of cannabis
- 314 kilos of cocaine
- 157 kilos of heroin
- 121 kilos of methamphetamine
- 13 criminal apprehensions
- Over \$5 million in illicit U.S. Currency.

K9 Roman made his final seizure just days prior to retiring, recovering 20 Kilos of cocaine during a traffic stop on September 23, 2024.

K9 Roman was a proven asset to the ISP, and his contributions will be profoundly missed. The dedication and hard work of Master Sergeant Veryzer and Canine Roman have left a lasting impression on the Illinois State Police Canine Section and set a high standard for K9 teams everywhere.

ISP Makes Arrest for Attempted Murder

MAROA – Illinois State Police (ISP) Division of Criminal Investigation (DCI) Zone 5 announces the arrest of 36-year-old Matthew R. Broadhacker of Maroa, IL for Attempted Murder (Class X Felony), Aggravated Domestic Battery (Class X Felony), and Aggravated Battery (Class X Felony).

On September 28, 2024, the Maroa Police Department (MPD) responded to a 911 call at a residence in the 400 block of N. Maple Street in Maroa, IL. Upon arrival, MPD located a female victim with burn injuries. The female was transported to an area hospital with life-threatening injuries. ISP DCI Zone 5 agents were requested by

the MPD to investigate this incident. The suspect, Matthew Broadhacker, remained on scene and was immediately taken into custody by MPD.

On October 1, 2024, the Macon County State's Attorney's Office charged Broadhacker with the

above charges. Broadhacker remains in custody at the Macon County Jail.



ISP Arrests Chicago Woman After Fatal Pedestrian Crash on Dan Ryan Expressway

CHICAGO – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 arrested 47-year-old Ronne L. Watson of Chicago, IL, for Aggravated Driving Under the Influence Resulting in Death (Class 2 Felony).

On October 6, 2024, at approximately 1:34 a.m., ISP Troop 3 responded to a report of a pedestrian struck by a vehicle while walking on the Dan Ryan Expressway, Interstate 94 northbound near 83rd Street. The suspect vehicle left the scene and the pedestrian was declared deceased. At approximately 1:48 a.m., University of Chicago Police Department located the suspect vehicle and conducted a traffic stop in the vicinity of Hyde Park Boulevard and Woodlawn Avenue. The driver of the vehicle identified as Ronne L. Watson was placed under arrest for Driving Under the Influence of Alcohol.

On October 7, 2024, after a thorough investigation ISP Agents presented the case to the Cook County State's Attorney's Office and the above-mentioned charge was approved. Watson is being held at the Riverdale Police Department until her pretrial hearing.

ISP Arrests Bridgeview Man for Fatal Pedestrian Crash on Stevenson Expressway Ryan Expressway

CHICAGO – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 announces the arrest of 26-year-old Geraldo D. Flores of Bridgeview, IL for Failure to Report an Accident Resulting in Death (Class 1 Felony).

On September 8, 2024, ISP Troop 3 officers responded to the report of a pedestrian walking on the Stevenson Expressway. At approximately 5:05 a.m., troopers were advised that a pedestrian had been struck by a vehicle on Interstate 55 southbound under Interstate 94. Upon arrival troopers discovered the deceased pedestrian and vehicle debris, but no suspect vehicle. An extensive investigation ensued. A suspect vehicle and alleged driver, identified as Flores, were identified.

On October 7, 2024, Flores turned himself in to ISP officers, and the Cook County State's Attorney approved the above-mentioned charge. Flores is being held at the Riverdale Police Department until his first court hearing.

There were several notable events and arrests during the detail.

On October 1, 2024, troopers conducted a traffic stop on a vehicle for IVC violations. During a subsequent search of the vehicle, troopers located and seized a loaded firearm with no identifiable features, commonly known as a "Ghost gun." One subject was taken into custody.

On October 2, 2024, troopers conducted a traffic stop on a vehicle for IVC violations. A subsequent search of the vehicle resulted in the seizure of approximately 46 grams of suspected fentanyl, a loaded handgun, and an additional loaded firearm magazine. Two subjects were taken into custody.

On October 2, 2024, troopers conducted a traffic stop on a vehicle for an IVC violation. The vehicle stopped and the driver attempted to walk away from the troopers. Troopers detained the driver

ISP Investigates Officer Involved Shooting in Mount Carmel

MOUNT CARMEL – The Mount Carmel Police Department (MCPD) requested the Illinois State Police (ISP) Division of Criminal Investigation (DCI) Zone 8 to investigate an officer involved shooting that occurred October 10, 2024, at approximately 9:18 p.m. MCPD officers responded to a domestic disturbance in the 40 block of Lambert Drive, Mount Carmel, Wabash County.

Preliminary investigative findings indicate upon arriving at the above residence, members from the MCPD encountered a juvenile suspect with a knife. An officer discharged their firearm, striking the suspect and another juvenile. Officers immediately rendered aid to both individuals who were transported to an area hospital. The suspect was pronounced deceased by the Wabash County Coroner.

ISP continues to investigate the officer involved shooting and will provide its findings to the Wabash County States Attorney's office for review once complete. The investigation is ongoing and no additional information is available at this time.

ISP Announces I-57 Traffic Safety Enforcement Operation Results

Troopers step-up efforts along I-57 corridor to reduce crashes and save lives

PESOTUM – Illinois State Police (ISP) officers from eastern and southern Illinois joined forces to combat aggressive and unsafe driving behaviors along Interstate 57 from October 3-7, 2024. The operation focused its efforts on Interstate 57, starting at milepost zero in Alexander County all the way up to milepost 257 on the northern Champaign County border.

Patrol officers from ISP Troops 7, 9, and 10, with assistance from ISP central and south Special Operations Group's Fatal Four team saturated the interstate, enforcing Illinois Vehicle Code violations, especially speeding. Speeding is a contributing factor in nearly <u>one-third</u> of all fatality crashes. Officers also focused on Motor Carrier Safety Inspections for commercial motor vehicles, a function unique to ISP officers. Over a <u>quarter</u> of all fatal crashes involving large trucks occur on the interstate. By focusing on this known data and taking proactive steps to correct unsafe driving behavior, ISP strives to decrease fatal and personal injury crashes on the interstate.

It should be noted that during this high-visibility traffic enforcement detail there were no fatal crashes, and only five accident reports filed for all 257 miles of Interstate 57.

As ISP's increased enforcement to save lives and combat personal injury and fatal crashes on the interstate systems has evolved, the need for additional troopers to carry out this important work has increased. ISP recently increased the incentive to become an ISP trooper and enforce these missions and values. Effective July 1, 2024, all new ISP troopers will receive approximately \$90,000 in compensation upon graduation from the Illinois State Police Academy.


ISP reminds the public that the Move Over Law, also known as "Scott's Law," requires all drivers to move over when approaching an emergency vehicle, or any vehicle with its emergency or hazard lights activated. A person who violates the Move Over Law faces a fine of no less than \$250 and no more than \$10,000 for a first offense.

ISP Arrests Springfield Woman for Man's Death in Waverly

WAVERLY – Illinois State Police (ISP) Division of Criminal Investigation Zone 4 agents arrested 39-year-old Kavita Lettimore of Springfield, IL for Involuntary Manslaughter (Class 2 Felony).

On February 21, 2024, the Waverly Police Department requested ISP to investigate a death that occurred on February 18, 2024, in the 300 block of West State Street. ISP conducted a thorough investigation and discovered that someone interfered with the victim's medical device which lead to the victim's death. The victim was identified as 39-year-old Randy L. Lettimore.



On October 15, 2024, ISP presented its case to the Morgan County State's Attorney's Office and Lettimore was charged with Involuntary Manslaughter. On the same day ISP agents located Lettimore in Sangamon County and took her into custody. She is currently being held at the Sangamon County Jail pending transfer back to Morgan County, where she will have her first court appearance.

ISP Arrests Man for Washington Park Murder

WASHINGTON PARK – Illinois State Police Division of Criminal Investigation Zone 6 announces the arrest of 22-year-old Steven Tiller Jr. of Belleville, IL for First Degree Murder (Class M Felony) and Unlawful Possession of a Weapon by a Felon (Class 2 Felony) stemming from a deadly shooting this past March.

On March 29, 2024, Zone 6 agents were requested by the Washington Park Police Department to investigate a homicide that occurred outside of a business in the 6000 block of Forest Blvd. in Washington Park. 39-year-old George Smith of East St. Louis died at an area hospital after being struck by gunfire.



After a thorough investigation, ISP agents identified Tiller as a suspect. On October 11, 2024, Tiller was taken into custody. Tiller is charged with First Degree Murder and Unlawful Possession of a Weapon by a Felon and is being held at the St. Clair County Jail.

K9s and Handlers Train to Survive

Five canine handlers from ISP's Canine Section recently attended a weeklong training course in Butlerville, IN, provided by the American Tactical K9 Association. The training focused on skills K9 handlers need to increase their survivability while deploying their K9 partner.

Teams were presented with scenarios based on real world experiences and were required to

manage the scenario using current training methods. Topics covered included patrol K9 deployment methods utilizing a variety of equipment, how to survive lethal threats, human and K9 tactical emergency casualty care, and legal considerations. The five days of training combined classroom instruction, K9 and handler exposure exercises, and scenario-based training exercises utilizing Simunitions.

ISP Accepting Cadets, Starting Pay is \$90,000

SPRINGFIELD – People looking to be part of something bigger in the Chicagoland area and earn a starting pay of \$90,000 after graduation still have until November 1, 2024, to meet the application deadline for Illinois State Police (ISP) cadet classes 151 and 152. Physical fitness testing and recruitment exams are happening right now, and cadets will check-in to the ISP Academy in June 2025.



"The Illinois State Police is one of the most prestigious law enforcement agencies in the country," said ISP Director Brendan F. Kelly. "We're looking for individuals with physical and moral courage, dedicated to fighting crime, protecting communities, and pursuing justice."

In addition to patrolling interstates 1-55, I-80, I-57, I-355, I-290, and I-53, as well as rural and unincorporated areas around Chicago, ISP offers opportunities in multiple specialized work units including SWAT, crime scene services, criminal investigation, air operations, K9, 911, and others. ISP has troopers across the entire state with the largest number in the Chicago area.

ISP offers two types of cadet classes. Traditional classes are for individuals new to law enforcement, while lateral clas-

ses are for current officers looking for increased opportunities and great pay. ISP has taken the 30X30 pledge to increase the representation of women in cadet classes to 30% by 2030. Upon graduation, troopers earn a total of \$90,000, with benefits.

Trooper Brian Frank Awarded the Illinois Law Enforcement Medal of Honor

SPRINGFIELD - October 16, 2024, Governor JB Pritzker and Illinois State Police (ISP) Director and Illinois Law Enforcement Medal of Honor Committee Chair Brendan F. Kelly presented the Illinois Law Enforcement Medal of Honor to ISP Trooper Brian Frank in recognition of his exceptional bravery and sacrificial service to the residents of Illinois.

On February 15, 2021, **ISP Trooper Brian** Frank was seriously injured as a result of a Move Over Law violation, known as Scott's Law in Illinois. Trooper Frank was responding to a traffic crash in Will County and pulled behind the wrecked vehicles in the left lane with his emergency lights activated. Another car crashed into the rear

of Trooper Frank's squad car causing incapacitating injuries to him. The driver was charged with Aggravated Reckless Driving and for violating the Move Over Law.

"One of the highest distinctions in all of law enforcement, the Medal of Honor is awarded to brave officers who put themselves in harms way to keep Illinoisans safe and protected," said Governor JB Pritzker. "Trooper Frank, in his service to Illinois State Police, and in the example he has set during his recovery, has set a high standard of bravery and made our state a better and safer place — especially for his fellow officers. This Medal of Honor will not even begin to repay Trooper Frank's sacrifices, but I hope it serves as a reminder

of the reverence we hold him in and the incredibly positive impact of his service."

The Illinois Law Enforcement Medal of Honor is awarded by the Law Enforcement Medal of Honor Committee to officers who have been killed or seriously injured in the line of duty, or who have displayed exceptional bravery or her-



as a law enforcement officer. Due to his ongoing recovery efforts, Trooper Frank has been unable to attend previous awards ceremonies.

"There are not enough words to express the extreme gratitude for Trooper Brian Frank's selfless sacrifice, nor the words to convey the heartache for his debilitating injuries," said Committee Chair Kelly. "It is truly an honor to award Trooper Brian Frank the Illinois Law Enforcement Medal of Honor."

Today, Trooper Frank received the award alongside his wife, Lauren Frank, who is a strong Move Over Law advocate. Trooper Frank has persevered through an extensive rehabilitative journey, and with the support of family, friends, and the community at large, he courageously continues to work towards recovery.

"Navigating Brian's severe traumatic brain injury recovery and aftermath has been the hardest thing I ever could have imagined," said Lauren Frank. "We are 3.5 years out and still waiting for Brian to return to full consciousness. The setbacks,

> the complications, the legal matters, the medical bills, the home life adjustments, just to name a few obstacles since the crash, have been incomprehensible. I am grateful to take a moment to pause and recognize Brian for the hero that he is. Amidst all the heartache, he deserves to be celebrated for surviving

oism while performing their duties another year against all odds, for the sacrifice he made, risking and ultimately giving his life, to protect others. I am so proud of Brian and it is my honor to love him and fight alongside him for his healing. For today, this acknowledgment with the Medal of Honor is certainly a gift."


Trooper Ray Embree

End of Watch: October 15, 1936

Trooper Ray Embree was killed in an automobile accident while returning to the district headquarters in Springfield. He and a Secretary of State employee were returning from Chicago after delivering documents for the Governor. For unknown reasons Trooper Embree's automobile swerved into the path of an on-

coming tractor trailer on Route 66, near Towanda. Trooper Embree was transported to Normal Hospital where he succumbed to his injuries. His passenger did not receive any injuries.

Trooper Embree served with the Illinois State Police for ten months and was assigned to District 9. Trooper Embree was survived by his wife and child.
