ISP Arrests O'Fallon, IL Man for Murder at Samuel Gomper Homes

EAST ST. LOUIS – The Illinois State Police (ISP) Division of Criminal Investigation (DCI) Public Safety Enforcement Group (PSEG) arrested 18-year-old Ricky T. Clayton of O'Fallon, IL for First Degree Murder (Class M Felony).

On December 22, 2024, ISP agents were requested by the East St. Louis Police Department to assist with a homicide investigation that occurred at the Samuel Gomper Homes located in the 400 block of North 6th Street. The victim, 21-year-old, Markela Howliet of East St. Louis, IL had been shot outside in a parking lot and later pronounced deceased.

After a thorough investigation, with assistance from the East St. Louis Police Department, the case was presented to the St. Clair County State's Attorney James Gomric, and the above-mentioned charge was filed against Clayton on January 31, 2025.

Clayton was currently in-custody during the issuance of charges. No further information is available.

ISP Arrests Chicago Man for Weekend Shooting

CHICAGO – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 arrested 32-year-old Reginald Brown from Chicago, IL for Aggravated Possession of a Weapon by a Felon (Class X Felony) and Aggravated Fleeing to Elude (Class 4 Felony). The charges stem from an expressway shooting on January 31, 2025, at approximately 11:10 p.m.

On the above-mentioned date and time, ISP officers responded to a non-injury expressway shooting on Interstate 94 northbound express lanes near 47th Street in Chicago. On February 1, 2025, a suspect vehicle was identified and located on Interstate 94 southbound near 91st Street. A traffic stop was attempted but the vehicle failed to stop. ISP units pursued the vehicle and with assistance from a Chicago Police Department helicopter, the vehicle was seen parking in the 2100 block of 98th Place in Chicago. Brown surrendered to authorities and was taken into custody.

The Cook County State's Attorney's Office approved the above-mentioned charges against Brown. Additional charges are pending. There is no further information.

ISP Still Seeking Public's Help in Macon County Homicide

DECATUR – The Illinois State Police (ISP) Division of Criminal Investigation (DCI) Zone 5 requests the public's assistance with the death investigation of 51-year-old James E. Taylor of Decatur, IL.

On May 19, 2023, Taylor was found deceased in a rural area near his home. He was reported missing on May 12, 2023, to the Decatur Police Department and was last seen alive on May 10, 2023, at approximately 6 p.m. ISP agents are investigating the death as a homicide.

Arrests Made in Expressway Shootings

CHICAGO – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 arrested 22-year-old Kenneth Curry III of Joliet, IL, for Aggravated Discharge of a Firearm (Class 1 Felony) stemming from a road rage incident in 2023.

On November 13, 2023, at approximately 4:18 p.m., ISP responded to the report of an express-way shooting on the Dan Ryan Expressway, Interstate 94 southbound near 120th Street. The suspect, later identified as Curry III, reportedly fired a weapon at the victim's vehicle. The victim's vehicle was struck multiple times, but the victims were not injured.

On February 3, 2025, ISP and FBI agents located Curry and took him into custody. ISP presented the case to the Cook County State's Attorney's Office and the above-mentioned charge was filed. Curry III is being held at the Chicago Police Department 5th District pending his first court appearance. No further information is available.

CHICAGO – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 arrested 47-year-old Miguel Gonzalez from Waukegan, IL for one count of Aggravated Battery with a Firearm (Class X Felony) and four counts of Aggravated Discharge of a Firearm (Class 1 Felony) related to an expressway shooting on the Kennedy Expressway in 2022.

On October 22, 2022, at approximately 4:30 a.m., ISP officers responded to a reported expressway shooting on Interstate 90 northbound near Fullerton in Chicago. The victim's vehicle was shot at by an occupant of another vehicle. The victim was struck by gunfire and was transported to an area hospital with non-life-threatening injuries. After an exhaustive investigation, agents identified a suspect vehicle and suspect.

On February 12, 2025, ISP agents, with the assistance of the FBI Fugitive Task Force, took Gonzalez into custody. Agents presented their case to the Cook County State's Attorney's Office and the above-mentioned charge was filed against Gonzalez. Gonzalez is being held pending his first court appearance. There is no further information.

ISP Investigates Officer Involved Incidents

MURPHYSBORO – The Illinois State Police (ISP) Division of Criminal Investigations Zone 7 was requested by the Murphysboro Police Department (MPD) to investigate an officer involved death.

On February 4, 2025, at approximately 1:30 a.m., an officer from the MPD attempted a traffic stop on a vehicle that had previously fled from other police agencies. The vehicle failed to stop and the MPD officer lost sight of the vehicle. The vehicle that failed to stop was located crashed near south 14th Street and Spruce Street in Murphysboro. The driver was pronounced deceased on scene. The passenger was transported to an area hospital with life-threatening injuries.

ISP is leading the open and ongoing investigation. No additional information will be released at this time.

LEXINGTON – The Illinois State Police (ISP) Division of Internal Investigation is investigating an officer involved shooting in McLean County.

On February 6, 2025 just after 9:35 a.m., ISP officers were alerted to a vehicle believed to be involved in an armed robbery in Texas traveling on I-74 in Champaign County. Officers began to track the vehicle as it headed north into McLean County. Around 10:30 a.m., the vehicle stopped at a gas station in Lexington and one occupant, 19-year-old Joseph Martin Hernandez from Texas, exited the vehicle and entered the gas station. Shortly after, officers arrived at the gas station and attempted to take Hernandez and the driver, 18-year-old Ryan Aeron Stanley Hurst from Arkansas, into custody. Hurst pointed a gun in the direction of officers and officers fired shots striking Hurst.

Officers began providing first aid until Hurst was transported to the hospital, where he is currently listed in stable condition. Hernandez was not injured and was taken into custody for further investigation. No officers were injured.

In accordance with the Police and Community Relations Improvement Act (50 ILCS 727) and the Illinois State Police Law (20 ILCS 2605), special agents of the Illinois State Police Division of Internal Investigation are investigating this incident.

This investigation is open and ongoing. ISP is currently processing evidence and conducting interviews. Upon completion of the investigation, all evidence and facts will be submitted for review to the McLean County State's Attorney's Office. No additional information is available at this time.

Woodridge Man Arrested for Possession of Child Sexual Abuse Materials

WOODRIDGE– Illinois State Police (ISP) Division of Criminal Investigation Zone 1 West special agents arrested 29-year-old Bryan J. Odwyer of Woodridge, IL for one count of Possession of Child Pornography (Class 2 Felony).

On September 10, 2024, ISP initiated an investigation after learning a Odwyer was possibly possessing child sex abuse materials. On January 31, 2025, a search warrant executed on electronics owned by Odwyer revealed child sex abuse material. Odwyer was taken into custody on February 19, 2025, and transported to the DuPage County Jail for a detention hearing. There is no additional information.

ISP Investigation Leads to Arrest for Murder of Teen

EAST ST. LOUIS – An Illinois State Police (ISP) Division of Criminal Investigation Public Safety Enforcement Group investigation led to the arrest of 19-year-old Celvin Rogers of East St. Louis, IL for First Degree Murder (Class M Felony), Armed Robbery / Discharge of a Firearm (Class X Felony), and Aggravated Unlawful Possession of a Weapon – No FOID/ FCCA (Class 4 Felony).

On February 8, 2025, ISP agents were requested by the East St. Louis Police Department to assist with a homicide investigation that occurred on 59th Street south of State Street in East St. Louis. The victim, 17-year-old, Parker Bujnak of Belleville, IL had been shot while standing outside of a vehicle. Bujnak was transported to a local hospital and later pronounced deceased.

After a thorough investigation, with assistance from the East St. Louis Police Department, the case was presented to the St. Clair County State's Attorney James Gomric, and the abovementioned charges were filed against Rogers on February 19, 2025.

Rogers was taken into custody in Missouri by the United States Marshals Service and is being held pending extradition to Illinois. No further information is available.

ISP Seeks Assistance to Identify Unknown Deceased Female

DES PLAINES – Illinois State Police (ISP) Division of Criminal Investigations Zone 1 continues to investigate the death of an unidentified woman from 2003 and are seeking the public's assistance to identify her.

On Saturday, July 12, 2003, a deceased human body was discovered floating in the Skokie River (approx. 1/4 mile south of Willow Road in the Erickson Woods / Skokie Lagoons area of Northfield and Winnetka, Illinois). The body was located south of Lagoon No. 1 and south of the dam on the Skokie River, not far from the N. Branch Trail System (see photo of approximate discovery site below). Upon removal from the water, it was discovered the deceased was a female, (unknown race), partially clothed.

Information from the autopsy provided the following identifying information:

Sex: Female , Race: Unknown (possibly White, Hispanic, or Asian), Estimated age at time of discovery: 20-39 years old (estimated year of birth 1964-1983) (the woman would be 42-61 years old if she were alive today in 2025), HGT: 502 , WGT: 147 (living weight estimated at 100-150lbs), Hair: Black or dark colored, long, straight, Dental: Dental care was good with only one amalgam restoration (metal filling), and a maxillary , four-unit fixed porcelain metal bridge replacing two missing central incisors which were well healed (bridge for two missing, upper front teeth). The dental replacement may have happened as a result of a traumatic injury earlier in the person's life. Clothing: Black Lycra shorts (bicyclist-style shorts). Jewelry: Scorpion ring (pictured)

ISP's Urban Policing Model Sees Homicides Drop to 6-Yr Low

Model area homicides down 26% in 2024, down 44% since inception

EAST ST. LOUIS – The Illinois State Police's (ISP) urban policing model, Public Safety Enforcement Group (PSEG), is reducing crime and building trust with the community, leading to a 6-year low in homicides in East St. Louis, the area covered by the model. ISP's combination of targeted antiviolence details, dedicated investigative resources, coordination with local law enforcement, implementation of new technology, partnerships with community organizations, and engagement in neighborhoods helped reduce homicides in 2024 by 26% compared to 2023, and non-fatal shootings by 32%. "Our state has one of the best police forces in the entire nation, and key anti-violence initiatives like their urban policing model in East St. Louis are delivering results and making our communities safer," said Governor JB Pritzker. "The numbers we're seeing today are not only a testament to ISP's commitment to community-building, but they are also a reminder of how important it is that we give law enforcement the proper resources and training they need."

"Seeing how violent crime undermines healthy development of communities, ISP implemented a new, urban policing model in 2020 that has reduced violent crime and strengthened public trust," said ISP Director Brendan F. Kelly. "Law enforcement can't do things to a community, or for a community, but must do things with a community, so ISP has dedicated additional resources and partnered with local law enforcement and community organizations to make neighborhoods safer." Since implementation of PSEG, which works with ISP Patrol Troop 8, the South Special Operations Group (SOG), Air Operations, Firearms Investigations Unit, and the Metropolitan Enforcement Group of Southwestern Illinois, the number of homicides and non-fatal shootings in East St. Louis has decreased each year. From 2019 through 2024, homicides are down 44% and non-fatal shootings are down 52%.

PSEG also partners with community organizations to assist those impacted by violent crime in the Metro East. The District 189 WrapAround Wellness Center (WWC) provides trauma services to children of East St. Louis who have witnessed or been victimized by violent crime. During 2024, the number of referrals to the WWC more than doubled, with PSEG agents referring 271 youths impacted by violent crime. Additionally, PSEG agents referred 210 adults and family members who were victims of violent crime to the Treatment Alternative for Safe Communities —Community Emergency Response Team. The Community LifeLine Family Resource Center is another PSEG partner that provides trauma services to victims of violent crime and their families.

Along with assisting those impacted by violent crime, PSEG works to build strong com-

munity relationships by participating in local events, as well as mentoring and helping area youth. During the 2024 holiday season, PSEG helped raise more than \$3,000 to purchase gifts for area children. Over the years, officers have volunteered their time to coach a team of middle school boys from the East St. Louis area for the Metro East Baseball League, and regularly go to community centers in housing developments to talk with and listen to youth. Each year, PSEG works to expand its presence in the community. Special agents more than doubled the number of referrals to WWC from 2023 to 2024 and increased community engagements more than 11%.

ISP has seen an overwhelming positive response from communities in the Metro East and statistics show this model is reducing violent crime. Since its creation in 2020, PSEG has opened more than 1,281 violent crime cases. Because of its success, ISP is working to expand this model to other areas of the state.

The PSEG urban policing model is being studied nationwide. The University of Chicago Crime Lab looked at the PSEG model and brought in International Policing Advisor Robert Wasserman, who has worked with law enforcement agencies across the country, including the New York Police Department, as well as in countries abroad.

"I spent some time in East St. Louis observing the Public Safety Enforcement Group, which is an unusual and quite amazing initiative undertaken not only by the Illinois State Police, but also by members of the East St. Louis community," said Wasserman. "PSEG is a stellar example of effective community policing and is a lesson for police agencies nationwide, including state police."

Federal judges who have heard of PSEG have inquired about the model as the St. Clair County State's Attorney's Office and the United States Attorney's Office for the Southern District of Illinois have been crucial in its success.

"The U.S. Attorney's Office is a proud partner of the PSEG policing model, which has allowed us to build better relationships with the East St. Louis community and prosecute violent crimes," said Acting U.S. Attorney Ali M. Summers. "We've presented the PSEG model to other U.S. Attorney's offices across the country with high reports of gun violence as an effective tool to improve public safety and support for victims." Specialized ISP patrol efforts are also making an impact. During 2024, South SOG conducted nine, multi-day patrol operations in St. Clair and Madison counties targeting known high crime areas, organized violent offenders, and structured criminal groups in regional communities. More than 250 ISP officers from around the state participated in

Along with additional patrol and investigative resource, ISP has expanded its use of technology. ISP's use of Automated License Plate Reader (ALPR) cameras has been instrumental in aiding criminal investigations and reducing violent crime through intelligence-led patrols in the region. Currently, there are 84 ALPR cameras in St. Clair and Madison counties, with more being planned.

As communities' needs for law enforcement change, ISP's approach will evolve in order to provide the best service and greatest protection to communities.



Trooper Arthur Goetting

End of Watch February 4, 1951 Trooper Arthur Goetting was killed when his patrol car struck the engine of an Illinois Central Railroad passenger train at the Peter's Station crossing on Route 157 in Madison County.

Trooper Goetting was killed on his one-year anniversary with the Illinois State Police and was assigned to District 11. Trooper Goetting was a WWII veteran and was survived by his wife.

Trooper Eugene Roberts was struck and killed by a vehicle while working a commercial vehicle weight enforcement detail on Route 34 near Aurora. He had just told a trucker to proceed to the weight pit and was struck by a car as he stepped off the truck's running board. He succumbed to his injuries the following day at St. Joseph Mercy Hospital.



Trooper Paul Clendening

End of Watch February 16, 1927 Trooper Paul Clendening was killed in an automobile accident on Lake Street in Elgin, Illinois. Trooper Clendening and his partner were searching for highway bandits when their car went out of control on ice. Trooper Clendening was thrown from the car and then pinned underneath it. Other officers arrived at the scene and it took six men to lift the car off of the trooper. He was transported to a local hospital where he succumbed to his injuries.

Trooper Clendening was a three-year veteran of the Illinois State Police, assigned to District 2, Elgin. He also served in the U.S. Marine Corps during WWI. Trooper Clendening was survived by his wife and two children.




