#### ISP Arrests Tilton Man for Possession of Child Sexual Abuse Materials

**TILTON** – Illinois State Police (ISP) Division of Criminal Investigation (DCI) Zone 5 special agents arrested 23-year-old Ryan N. Emory from Tilton, IL for 11 counts of Dissemination of Child Pornography - Child under 13 (Class X Felonies) and one count of Dissemination of Child Pornography - moving depiction (Class X Felony).

In November 2024, ISP agents received a cyber tip indicating that Emory was possibly possessing child sex abuse materials and an extensive investigation was initiated. On February 20, 2025, a residential search warrant was executed in the 1000 block of Glendale Avenue in Tilton. Emory was taken into cus-



tody and transported to the Vermilion County Public Safety Building for a detention hearing.

ISP agents were assisted by the Danville Police Department, Tilton Police Department, Vermilion County Metropolitan Enforcement Group, Vermilion County State's Attorney's Office and the Illinois Attorney General's Office Internet Crimes Against Children Task Force.

#### ISP Investigates Shooting in St. Clair County

**BELLEVILLE** – An Illinois State Police (ISP) Division of Criminal Investigation Zone 6 investigation resulted in six charges against 28-year-old Chase A. Powers of Belleville, IL, including attempted murder.



On February 20, 2025, ISP agents were requested by the St. Clair County Sheriff's Department (SCCSD) to investigate a shooting. SCCSD responded with an

investigator from the Illinois Department of Children and Family Services to a residence in the 700 block of South 15th Street in Belleville to check the wellbeing of a child living at the residence. While at the residence, an altercation occurred between investigators and Powers. Powers disarmed one of the officers and the firearm was discharged. No one was injured as a result of the firearm being discharged. Powers was taken into custody and transported to the St. Clair County Jail.

After a thorough investigation, the case was presented to St. Clair County State's Attorney James Gomric, who filed six charges against Powers on February 21, 2025 for Attempted Murder (Class X Felony), Aggravated Discharge of a Firearm (Class X Felony), Aggravated Battery/Great Bodily Harm of Police Officer (Class 1 Felony), Disarming a Police Officer (Class 1 Felony), Felon in Possession of a Weapon (Class 2 Felony), Aggravated Battery of Police Officer (Class 2 Felony). Powers is being held at the St. Clair County Jail.

#### ISP Continues to Uphold Public Integrity

**ROCKFORD** – Illinois State Police (ISP) Division of Criminal Investigation (DCI) Zone 2 continues to uphold public integrity with a recent case involving charges against a former Jackson Charter School Executive Director. ISP worked with the Winnebago County State's Attorney's Office to bring charges against 39-year-old Emily A. Wallen.




In September 2024, ISP received an allegation of theft and official misconduct against former Jackson Charter School Executive Director Emily A. Wallen. ISP immediately began an

investigation into Wallen's conduct and special agents found evidence Wallen knowingly used Jackson Charter School funds for personal gain during the time of her previous employment.

On February 24, 2025, after a thorough investigation, an arrest warrant was issued for Wallen for one count of Theft \$10,000 - \$100,000 (Class 2 Felony) and one count of Official Misconduct (Class 3 Felony). ISP arrested Wallen, and she was taken to the Winnebago County Jail.

#### ISP Arrests Man for Fatal Crash at Illinois Tollway Yard in Gurnee

**GURNEE** – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 Violent Crimes Unit special agents arrested 39-year-old Michael Vazquez of Oak Forest, IL for Aggravated Driving Under the Influence Involving Death (Class 2 Felony) stemming from a fatal crash in October.





property involving private contractor employees (not Tollway employees) who were laying asphalt. One of the private contractor employees, Vazquez, was driving a skid steer when he backed up and ran over another contracted employee, identified as 39-year old Gregory Bolls of Chicago. Bolls was transported to an area hospital and later died of his injuries.

After a thorough investigation, it was determined Vazquez had cocaine in his system at the time of the crash. On February 25, 2025, the Lake County State's Attorney's Office approved an Aggravated DUI charge and a warrant was issued for Vazquez. On February 27, 2025, Vazquez surrendered himself to the Lake County Jail.

#### ISP Leads Human Trafficking Demand Suppression Operation in Lincolnshire

**LINCOLNSHIRE** – The Illinois State Police (ISP) Division of Criminal Investigation Trafficking Enforcement Bureau arrested four individuals during a two-day human trafficking demand suppression operation in the Lincolnshire area of Lake County on February 25 - 26, 2025. The operation focused on identifying individuals seeking to engage in commercial sex acts.

As a result of the operation, the following individuals were arrested and charged:



• Timothy Hansen (57) of Lake Bluff, IL – Traveling to Meet a Minor (Class 3 Felony), Indecent Solicitation of a Child (Class 3 Felony), Solicitation to Meet a Child (Class 4 Felony), and Solicitation of a Sexual Act (Class A Misdemeanor).



• Elijah Newell (40) of Chicago, IL – Traveling to Meet a Minor (Class 3 Felony), Indecent Solicitation of a Child (Class 3 Felony), Solicitation to Meet a Child (Class 4 Felony), and Solicitation of a Sexual Act (Class A Misdemeanor).



• Sean Powers (38) of Geneva, IL – Traveling to Meet a Minor (Class 3 Felony), Indecent Solicitation of a Child (Class 3 Felony), Solicitation to Meet a Child (Class 4 Felony), and Solicitation of a Sexual Act (Class A Misdemeanor).



• Edas Romero-Chinchilla (32) of Round Lake Heights, IL—Traveling to Meet a Minor (Class 3 Felony), Indecent Solicitation of a Child (Class 3 Felony), Solicitation to Meet a Child (Class 4 Felony), and Solicitation of a Sexual Act (Class A Misdemeanor).

This operation was part of a multifaceted approach by ISP aimed at stopping human trafficking in Illinois. ISP special agents, officers from Troops 3 and 6, ISP SWAT, ISP Analysts, North Central Narcotics Task Force, Intelligence Support Unit, and the Lake County Metropolitan Enforcement Group partnered for the operation. The Lake County State's Attorney's Office also provided support for the operation.

Human trafficking is the use of force, fraud, or coercion to compel a person into commercial sex acts, labor, or services against their will. ISP continues its multifaceted approach toward protecting those most vulnerable with its ongoing statewide human trafficking enforcement operations. #### ISP Arrests Chicago Man for 2023 Vehicular Hijacking

**CHICAGO** – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 arrested 34-year-old Eric D. Evans from Chicago, IL for one count of Vehicular Hijacking (Class 1 Felony) for forcefully hijacking a vehicle in 2023.

On June 4, 2023, at approximately 5:30 a.m., ISP officers responded to a reported vehicular hijacking on Interstate 290 near Central Avenue in Chicago. The victim's vehicle was taken by an occupant within the vehicle after a physical



altercation and with the assistance of two other accomplices. After an exhaustive investigation, agents identified one suspect as Evans.

On February 28, 2025, ISP agents met with Evans in the Cook County Department of Corrections (CCDOC) while Evans was in custody on unrelated charges. Agents presented their case to the Cook County State's Attorney's Office and the above-mentioned charge was filed against Evans. Evans is currently in the custody of CCDOC.

# ISP Arrests Alsip Man for 2024 Murder



**CHICAGO** – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 arrested 32year-old Darius Norwood from Alsip, IL for one count of First-Degree Murder (Class M Felo-

ny) related to an expressway shooting on Interstate 94 in 2024.

On June 7, 2024, at approximately 9:50 p.m., ISP officers responded to a crashed vehicle with a deceased gunshot victim on Interstate 94 northbound in the local lanes near 37th Street in Chicago. After an exhaustive investigation, agents identified a suspect.

On February 26, 2025, the Alsip Police Department took Norwood into custody and later transferred custody to ISP agents. Agents presented their case to the Cook County State's Attorney's Office and the above-mentioned charge was filed against Norwood. Norwood is being held pending his first court appearance.

## ISP Releases Video of Officer Involved Shooting in McClean County

**LEXINGTON** – The Illinois State Police (ISP) Division of Internal Investigation (DII) continues its investigation into an officer involved shooting in McLean County.

On February 6, 2025 just after 9:35 a.m., ISP officers were alerted to a vehicle believed to be involved in an armed robbery in Texas traveling on I-74 in Champaign County. Officers began to track the vehicle as it headed north into McLean County. Around 10:30 a.m., the vehicle stopped at a gas station in Lexington and one occupant, 19-year-old Joseph Martin Hernandez from Texas, exited the vehicle and entered the gas station. Shortly after, officers arrived at the gas station and attempted to take the driver, 18-year-old Ryan Aeron Stanley Hurst from Arkansas, into custody. Hurst pointed a gun at officers and officers exchanged gunfire striking Hurst. Officers began providing first aid until Hurst was transported to the hospital, and has since been released. Hernandez was not injured and was taken into custody for further investigation. No officers were injured.

Hurst is currently housed in the McLean County jail on three counts of Attempted First-Degree Murder, four counts of Aggravated Discharge of a Firearm, and one count of Aggravated Assault.

#### ISP Recovers Deceased Bald Eagle, Provides Remains to Native American Tribes



**Knox County, IL** – Illinois State Police Troop 4 officers recently discovered a deceased Bald Eagle on the ice in the Spoon River in Knox County. The eagle, a symbol of national pride and conservation, was found by the officers during their routine patrol in the area.

Upon the discovery, Troop 4 immediately contacted both the Illinois Department of Natural Resources (DNR) and U.S. Fish and Wildlife Service to ensure the appropriate handling of the bird. With assistance from a local outdoorsman, the eagle was safely retrieved from the ice-covered river. The Bald Eagle, which is a protected species under the Bald and Golden Eagle Protection Act, will now be sent to the National Eagle Repository in Colorado.


The National Eagle Repository plays a vital role in distributing eagle remains to federally recognized Native American tribes across the United States. Currently, there are 574 tribes that request parts or entire eagles for religious and cultural ceremonies. The transfer of the eagle to this repository ensures that it will be used respectfully in accordance with tribal traditions.

#### ISP Squad Car Struck on I-57 in Kankakee County

ISP Experiences 3rd Move Over Law-Related Crash of 2025

CHEBANSE – Illinois State Police (ISP) officials investigated a traffic crash that occurred on I- 57 involving an ISP trooper, who had just finished removing debris from the roadway, when their squad car was struck by a driver who failed to move over.

On March 1, 2025, at approximately 1:49 p.m., an ISP trooper responded to a report of debris in the roadway at mile post 302 near Chebanse. The



trooper parked their squad car in the right lane of travel with emergency lights activated and removed the debris. The trooper returned to their squad car and the squad car was struck in the rear by a Lincoln SUV that failed to move over. The trooper was transported to an area hospital with non-life-threatening injuries. The driver of the Lincon, 66-year-old Harold McComb from Mahomet, Illinois, was transported to an area hospital with minor injuries. McComb was cited for Failure to Reduce Speed to Avoid an Accident and a Scott's Law violation.

In 2025, ISP has already suffered three Move Over Law-related crashes. In 2024, ISP suffered 27 Move Over Law-related crashes with 12 troopers injured and one death. In 2023, ISP had 21 Move Over Law-related crashes with seven troopers injured. ISP reminds the public the Move Over Law, also known as "Scott's Law" in Illinois, requires all drivers to move over when approaching an emergency vehicle or any vehicle with its emergency or hazard lights activated.

#### Troopers Face Danger to Stop Wrong-Way Driver

Early Sunday morning, February 23, 2025, two Troop 6 officers intercepted a wrong way DUI driver on Interstate 72 near Jacksonville (Morgan County) before they were able to hurt or kill another motorist.

The troopers located the wrong-way vehicle and positioned their squad cars to block the driver. The suspect vehicle struck the passenger side of Trooper Kaiser's squad causing full airbag

deployment and significant damage.

Fortunately, the Trooper in this squad wasn't injured. The driver of the vehicle was cited for DUI.



#### ISP K9 DuQ Receives Donation of Body Armor



**DUQUOIN** – Illinois State Police K9 DuQ has received a bullet and stab protective vest thanks to a charitable donation from non-profit organization Vested Interest in K9s, Inc. K9 DuQ's vest was sponsored by Vested Interest in K9s and embroidered with the sentiment "Born to Love - Trained to Serve - Loyal Always".

Vested Interest in K9s, Inc., established in 2009, is a 501(c)(3) charity whose mission is to provide bullet and stab protective vests and other assistance to dogs of law enforcement and related agencies throughout the United States. This potentially lifesaving body armor for four-legged K9 officers is U.S. made, custom fitted, and National Institute of Justice 9NIJ) certified. Since its inception, Vested Interest in K9s, Inc. has provided over 5,918 vests valued at \$6.9 million to K9s in all 50 states made possible by both private and corporate donations.

The program is open to U.S. dogs that are at least 20 months old and actively employed and certified with law enforcement or related agencies. K9s with expired vests are also eligible to participate. There are an estimated 30,000 law enforcement K9s throughout the United States.




Special Agent Robert Kolowski passed away at Saint Joseph Medical Center in Joliet Illinois.


