

ISP Memorial Park Wall Inscription Ceremony

*Troopers Thompsen and Carns
Honored and Remembered*

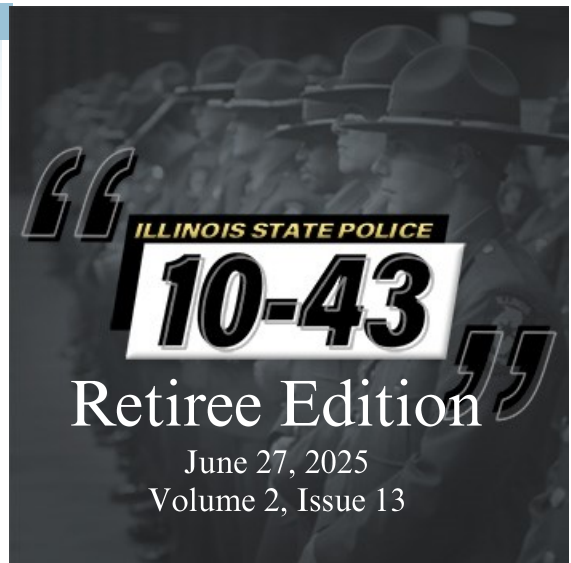
The Illinois State Police (ISP), Illinois State Police Heritage Foundation (ISPHF), and family and friends unveiled the names of Trooper Corey Thompsen #7081 and Trooper Clay Carns #6512 on the ISP Memorial Park wall in Springfield during individual ceremonies today. Both Trooper Thompsen and Trooper Carns were killed in the line of duty in 2024.

“The names engraved on the ISP Memorial Park wall are not just letters in granite, but a reminder to honor all the brave ISP troopers who were so dedicated to public service, they laid down their lives for us,” said ISP Director Brendan F. Kelly. “Their service and sacrifice are now forever memorialized on the wall and will never be forgotten.”

“The Illinois State Police Memorial Park wall is etched with the names of those ISP troopers who have made the ultimate sacrifice in service to the people of Illinois,” said ISPHF Executive Director Jarod Ingebrigtsen. “The wall is a stark reminder of the dangerous job troopers face each day. It also is a way to honor the men and women who selflessly served as well as those who will come after us to carry on the tenets of Integrity, Service and Pride.”

On October 18, 2024, Trooper Corey Thompsen had just completed a traffic safety detail on Interstate 57. Thompsen was traveling east on East Leverett Road approaching County Road 1300E in Champaign County when a pick-up truck traveling south on 1300 E. Road pulled into the intersection, striking Trooper Thompsen’s motorcycle. Thompsen was taken to an area hospital where he succumbed to his injuries. Thompsen was 28 years old and served almost five years as an officer with ISP. He is survived by his wife Chelsea, his parents Susan and Steve, and his brothers Mitchell and Ryan.

“This wall represents so much more than honoring the troopers lost while doing a job they loved. It symbolizes the number of devastated families, the quiet homes that were once filled with laughter, the dreams lost, and the futures that once seemed so bright but now only fill those left behind with sadness,” said Chelsea Thompsen. “Even though this wall reminds me of the worst day of

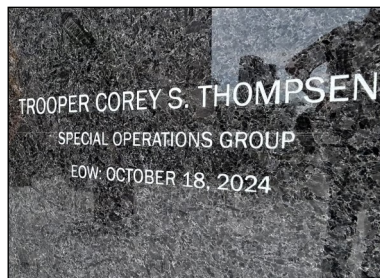
my life, I am grateful for one thing, Corey will never be forgotten. Thank you for honoring my husband and my best friend by making Corey, along with so many others, to become eternal.”

On December 23, 2024, Trooper Carns was outside of his squad car removing debris from a lane on southbound I-55 north of Blodgett Road near Channahon when he was struck by a passing vehicle. Trooper Carns was taken to St. Joseph Hospital in Joliet, where at approximately 10:45 p.m., he succumbed to his injuries.

Trooper Carns was 35 years old and served 11 years as an officer with ISP. He was assigned to Troop 3. He is survived by his wife Meghan, children Gray and Ally, parents Patti and Danny Carns, and Erica and Tony, Chad and Becca, Elyssa, Rosalie, and Neal and Debbie.

“We are forever proud of the man Clay was and the heroic way he lived his life,” said Meghan Carns, Clay’s wife. “We are proud to see him honored in this way.”

The Illinois State Police Memorial Park was dedication on October 2, 2018 and contains the names of 74 fallen heroes.

ISP Arrests Four on Child Sexual Assault Charges

FREEPORT—Illinois State Police (ISP) Division of Criminal Investigation Zone 2 arrested 66-year-old Steven M. Busiere of Freeport, IL for Possession and Dissemination of Child Pornography (Class X Felony).

On June 26, 2025, ISP agents executed a search warrant at Busiere’s residence in the 1700 block of East Shawnee Street in Freeport and collected electronic evidence. The evidence was analyzed and revealed child sexual abuse materials. ISP agents arrested Busiere and he was transported to the Stephenson County Jail. Busiere was charged with nine counts of Possession of Child Pornography and one count of Dissemination of Child Pornography.

SPRINGFIELD – Illinois State Police (ISP) Division of Criminal Investigation (DCI) Zone 4 Major Crimes agents arrested 26-year-old Justin Shull of Springfield, IL, for 10 counts of Possession of Child Pornography (Class 2 Felony).

In September 2024, ISP special agents began an internet crimes against children investigation in the Springfield area. During the investigation, ISP investigators assigned to the Office of the Illinois Attorney General Internet Crimes against Children Task Force (ICAC) gathered digital evidence indicating Shull possessed child sexual abuse material at his residence in Springfield. On June 18, 2025, ISP special agents arrested Shull and transported him to the Sangamon County Jail.

JOLIET – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 West special agents arrested 35-year-old Marty Johnson of Joliet, IL for two counts of Possession of Child

Pornography (Class 2 Felony).

ISP special agents began an internet crimes against children investigation in the Joliet area and identified the suspect as Johnson. In February of 2025, special agents interviewed Johnson and collected evidence of child sexual abuse materials. After a thorough investigation, ISP presented the case to the Will County State’s Attorney’s Office and the above-mentioned charges were approved. On June 18, 2025, ISP special agents arrested Johnson and transported him to the Will County Adult Detention Facility.

EDINBURG – Illinois State Police (ISP) Division of Criminal Investigation (DCI) special agents arrested 44-year-old William C. Wanless of Edinburg, IL for two counts of Possession of Child Pornography with the Intent to Disseminate (Class X Felony) and one count of Possession of Child Pornography with the Intent to Disseminate (Class 1 Felony).

On March 12, 2025, ISP special agents initiated a child sexual abuse material investigation. During the investigation, ISP special agents assigned to the Office of the Illinois Attorney General Internet Crimes Against Children Task Force gathered digital evidence indicating that Wanless possessed child sexual abuse material at his residence in Christian County.

On June 12, 2025, ISP special agents, the Edinburg Police Department, and the Office of Illinois Attorney General executed a search warrant at Wanless’s residence and took him into custody. The Christian County State’s Attorney’s Office filed the charges above. Wanless is being held at the Christian County Jail pending a detention hearing.

ISP Arrests Momence Man for Failing to Register as a Sex Offender

MOMENCE – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 West special agents arrested 47-year-old Carlos Luca of Momence, IL for Failure to Register as a Sex Offender (Class 3 Felony).

On June 12, 2025, ISP special agents were conducting a separate investigation and attempted to speak to Luca at his residence in Momence, IL. Luca refused to exit his residence and speak with officers. Special agents obtained a search warrant and took Luca into custody. Luca is required to register on the Child Sex Offender Registry for life due to a previous conviction for Aggravated Criminal Sex Abuse of a Victim under the Age of 16. Luca failed to register and was considered non-compliant. ISP special agents transported him to the Kankakee County Jail for processing.

ISP Leads Human Trafficking Demand Suppression Operation in Geneseo

GENESEO – Illinois State Police (ISP) Division of Criminal Investigation Trafficking Enforcement Bureau arrested four individuals during a two-day human trafficking demand suppression operation in the Geneseo area of Henry County on June 11 - 12, 2025. The operation focused on identifying individuals seeking to engage in commercial sex acts.

As a result of the operation, the following individuals were arrested and charged:

- Ryan J. Molln (47) of Walnut, IL – two counts of Indecent Solicitation of a Child (Class 2 Felony), two counts of Traveling to Meet a Minor (Class 3 Felony), two counts of Solicitation to Meet a Child (Class 4 Felony), and Grooming (Class 4 Felony)
- Juan C. Soto-Deanda (31) of East Moline, IL – Traveling to Meet a Minor (Class 3 Felony) and Solicitation to Meet a Child (Class 4 Felony).
- Marquis L. Lewis Sr. (45) of Davenport, IA – Traveling to Meet a Minor (Class 3 Felony) and Solicitation to Meet a Child (Class 4 Felony).
- Adrian Amezola (43) of Sterling, IL – Traveling to Meet a Minor (Class 3 Felony), Solicitation to Meet a Child (Class 4 Felony), Sexual Exploitation

of a Child (Class A Misdemeanor)

This operation was part of a multifaceted approach by ISP aimed at stopping human trafficking in Illinois. ISP Special Agents, ISP SWAT, ISP Analysts, ISP Intelligence Support Unit, Blackhawk Area Task Force, and the Henry County Sheriff's Office partnered for the operation. The Henry County State's Attorney's Office also provided support for the operation.

Human trafficking is the use of force, fraud, or coercion to compel a person into commercial sex acts, labor, or services against their will. ISP continues its multifaceted approach toward protecting those most vulnerable with its ongoing statewide human trafficking enforcement operations. ISP Arrests Chicago Man for DUI and Weapons Offense After Crash with IDOT Truck

CHICAGO – Illinois State Police (ISP) Division of Criminal Investigation Zone 1 Special Agents arrested 29-year-old Edward V. Gilbert of Chicago for Felon in Possession of a Weapon (Class 3 Felony) and Aggravated Driving Under the Influence – Accident Causing Great Bodily Harm (Class 4 Felony) after a serious-injury crash this weekend on the Dan Ryan Expressway.



On June 15, 2025, at approximately 2:24 a.m., ISP Troop 3 officers responded to I-94 southbound at 83rd Street in Chicago for the report of a crash. An Illinois Department of Transportation (IDOT) truck had its emergency lights and sirens activated and was preparing to stop for a disabled vehicle on the left shoulder. As the IDOT truck slowed in the left lane, a Hyundai Sonata rear-ended the IDOT truck. The driver of the Hyundai, identified as Gilbert, and his passenger, a 24-year-old female from Sauk Village, were both transported to an area hospital with serious injuries. The IDOT driver did not report any injuries. A loaded firearm was located inside the Hyundai.

ISP Special Agents presented their investigation to the Cook County State’s Attorney’s Office and on June 18, 2025, the abovementioned charges were filed. Custody of Gilbert has been transferred to the Cook County Sheriff’s Department until an initial hearing date will be con-

- **Casket guard protocol**

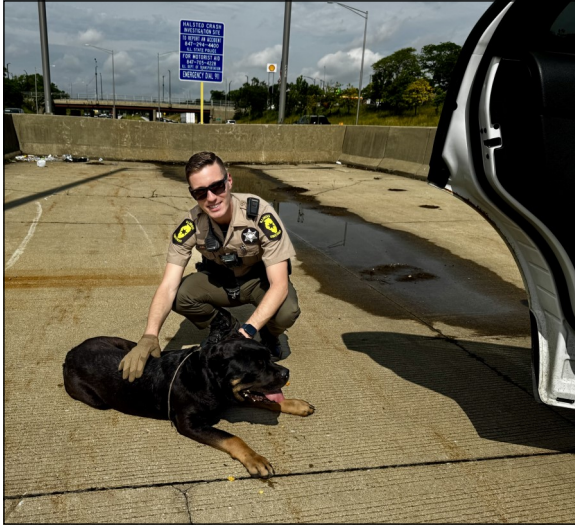
The training concluded with a full mock ISP Honor Guard detail in full dress uniform, giving members the opportunity to apply what they had learned in a realistic scenario.

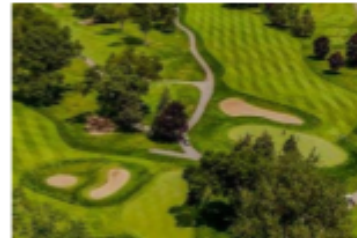

SGT. JOEL DECATUR

Susan, driving on I-294, was hit by a large truck. Sgt. Decatur responded to the incident. Overcome by the situation, Susan appreciated Sgt. Decatur's empathy and ISP's quick resolution:

"I was sideswiped by a semi and the semi driver left the scene. I could have been seriously hurt but came away with no physical injuries. Nevertheless, this was a very traumatic accident, and I completely broke down. I have a demanding job, we have moved out of our

house during a remodeling project, my husband had just had surgery, and our other car had been totaled less than a month earlier. This accident was the final straw for my stress level, and I began to sob uncontrollably. The fact that the driver had not stopped shook my faith in other people. That is how Sgt. Joel Decatur found me when he came to investigate the accident. He had the kindest demeanor anyone could ask for and displayed a genuine empathy for my situation. Because a witness saw what happened, she took a picture of the license plate and reported it to the highway patrol. Between her and Sgt. Decatur my faith in other people returned. He was clear with me about what had happened and said they would try to locate the driver. He called me immediately that evening to say that they had succeeded. Most of all, he kept calmly assuring me that cars can be fixed. I do not know what I would have done if a patrol officer had shown up who was grumpy and discourteous. You are so fortunate to have Joel Decatur as part of the ISP. Please recognize him for his professionalism and for his understanding when people are in such difficult situations. He is my idea of what the ideal patrol officer should be."

Stanley Talbot**

End of Watch
June 23, 2001

Master Sergeant Stanley Talbot died from injuries sustained from being drug by a driver who was fleeing a roadside safety checkpoint.

The incident occurred in Rock Island, Illinois at 15th Street and 2nd Avenue. As the vehicle neared the checkpoint, Master Sergeant Talbot approached it and be-

came entangled with the car as the driver fled the scene. Master Sergeant Talbot was dragged approximately half a mile before falling from the vehicle.

The driver of the vehicle was apprehended two weeks later and charged with two counts of murder.

On August 28, 2002, the driver was convicted of reckless homicide and leaving the scene of an accident. He was sentenced to 12 years in jail but was paroled in November 2005 after serving only 4 years.

Master Sergeant Talbot was a 26-year veteran of the Illinois State Police and planned to retire in six months; He was assigned to District 7, Rock Island.

Master Sergeant Talbot is survived by his wife and daughter, who are both members of the Illinois State Police, and a son who serves with the Collinsville Police Department.

Trooper Marvin Archer was shot and killed after he and his partner stopped a car for questioning in Paxton, Illinois. As the troopers approached the vehicle the driver jumped out and yelled his passenger had a gun. As Trooper Archer approached the car to arrest the second suspect he was shot in the chest and killed.

Trooper Archer had served with the Illinois State Police for five years and was assigned to District 21.
