ISP Arrests Beardstown Man for Murder

BEARDSTOWN – Illinois State Police (ISP) Division of Criminal Investigation (DCI) Zone 4 announces the arrest of 37-year-old Jean C. Santiago-Nieves of Beardstown, IL for First Degree Murder.

On Friday, May 31, 2024, the Beardstown Police Department (BPD) responded to a 911 call at residence in the 1400 block of Clay Street in Beardstown, IL. Upon arrival, BPD officers located a male subject deceased in a vehicle near the residence. The victim was later identified as Steve Dominguez (M/27) of Beardstown. ISP DCI Zone 4 agents were requested by the Beardstown Police Department to conduct a death investigation. The suspect, Santiago-Nieves, remained on scene and was immediately taken into custody.



After a thorough investigation, ISP presented its case to the Cass County State's Attorney's Office and a charge of First-Degree Murder was approved. Santiago-Nieves was transported to the Schuyler County Jail pending his first court appearance.

ISP Arrests Woman for Double Fatal Crash on Eisenhower Expressway

CHICAGO – The Illinois State Police (ISP) Division of Criminal Investigation Zone 1 announces the arrest of 21-year-old Ashanti Gates of Chicago, IL for two Counts of Aggravated Driving Under the Influence of Alcohol (Class 2 Felony), two Counts of Reckless Homicide (Class 3 Felony), and Child Endangerment (Class A Misdemeanor), stemming from a fatal crash earlier this week.

On June 2, 2024, ISP Troop 3 responded to a fatal crash on Interstate 290 (Eisenhower Expressway) westbound west of Paulina Avenue in Cook County. A white Toyota sedan had pulled on to the right shoulder, with its hazard lights on, due to a flat tire. The three occupants of the Toyota exited their vehicle to change the flat tire. A black Hyundai Sonata driven by Gates struck the parked Toyota and two of the Toyota's occupants that were changing the tire. The two victims, 18-year-old Erik C. Cox of Rolling Meadows, IL and 18-year-old Shaelyn M. Sherwood of Hoffman Estates, IL were declared deceased on scene. The third occupant from the Toyota was not struck. There were a total of five occupants in the Hyundai, including a 4-year-old male. Gates, the child, and one other person from the Hyundai were taken to area hospitals with injuries.

On June 3, 2024, the Cook County State's Attorney approved the above-mentioned charges. Gates is currently being held at the Chicago Police Department- 11th District.



ISP Investigation Leads to Attempted Murder Conviction in St. Clair County

EAST ST. LOUIS – The Illinois State Police (ISP) Public Safety Enforcement Group (PSEG) announces the conviction of 30-year-old Thomas A. Stocker, for Attempted First Degree Murder and Aggravated Battery with a Firearm, after a jury trial on April 4, 2024. He was sentenced on Tuesday, June 5, 2024, to serve 85 years in the Illinois Department of Corrections followed by three years of mandatory supervised release. By statute, Stocker is required to serve 85% of his sentence.

The evidence presented throughout the trial showed that Stocker, who had made the victim's acquaintance on a social media application, met with the victim in person on September 2, 2022 at Frank Holten State Park in East St. Louis before shooting the victim multiple times. Stocker then walked up to the victim, who had fallen to the ground, and fired a final shot into the victim's head. The victim was subsequently transported to St. Louis University Hospital for lifesaving treatment; how-

ever, a bullet still remained in the victim's head. An investigation by ISP PSEG agents led to an identification of Stocker and when he was apprehended, law enforcement officers located the firearm used during the commission of the crime.

State's Attorney James Gomric stated, "I want to thank the Court for handing down this strong sentence and my assistants who worked tirelessly on this case. Finally, I want to thank the men and women of the ISP for their thorough and professional investigation without which there could be no justice here. I wish the victim in this case the best on the path to recovery and hope that this sentence is some measure of closure."

The case was prosecuted by Assistant States Attorneys Derek Smith and Paris Bateman of the St. Clair County State's Attorney's Office Violent Crime Unit.

Reorganization of the Office of Strategic Planning

The Office of Research and Development (ORD) has been dissolved with the creation of two new units within the Office of Strategic Planning.

The Office of Metrics, Accreditation, and Policy (MAP) will assume responsibility for the management of the Illinois State Police (ISP) Directives System, Accreditation process management, Metrics reporting, and other related functions previously performed by the ORD. Lieutenant Timothy Good has been appointed as the Chief of the MAP. Chief Good is a 25-year veteran of the Department with over 26 years of law enforcement experience. He previously served as the Assistant Chief of ORD for seven years and brings a great depth of knowledge regarding agency policy and accreditation. The Office of Protective Security (OPS) will assume the responsibility for implementing the expanded respon-

sibilities mandated under Public Act 103-0034, which amends the Illinois State Police Law to increase the protective efforts for state assets and operations. These functions include strengthening the protection of state government facilities, employees, officials, and critical infrastructure through various means. Inspector John Mack has been appointed as the Chief of OPS. Chief Mack has over 23 years of service with the state, and 35 years overall of law enforcement experience. He brings a mix of subject matter expertise in the form of security management, threat assessment, training, and legal matters and will lead the Agency mission of incorporating subject matter expertise and law enforcement authority to fulfill the mandate. This change reflects the growing importance of these functions within ISP and State Government. ISP Announces Results of Violent Crime Suppression in Metro East

EAST ST. LOUIS – The Illinois State Police (ISP) conducted a violent crime suppression detail on June 3-5, 2024, in St. Clair and Madison counties, focusing its efforts on East St. Louis and neighboring Metro East communities. The operation utilized intelligence and technology to target known high crime areas, violent offenders, and structured criminal groups in the communities of the Metro East.

There were several notable arrests made during the detail.

On June 3, 2024, troopers made a traffic stop on a vehicle for an Illinois Vehicle Code (IVC) violation. A probable cause search was conducted, and a firearm, 5 grams of heroin, 6 grams of crack cocaine, 20 grams of cannabis and ecstasy pills were recovered.

On June 4, 2024, troopers made a traffic stop on a vehicle for an IVC violation. A probable cause search led to the recovery of a stolen handgun with an extended magazine.

On June 4, 2024, troopers observed four pedestrians commit an IVC violation. Troopers approached the four pedestrians, but they fled on foot. After a brief foot pursuit, two of them were apprehended. With the help of ISP K9's and their handlers, three firearms were recovered.

On June 5, 2024, troopers made a traffic stop on a vehicle for multiple IVC violations. A probable cause search was conducted, and a firearm was located along with ammunition. Both the driver and passenger were taken into custody for outstanding warrants.

On June 5, 2024, troopers made a traffic stop on a vehicle for an IVC violation. A probable cause search was conducted, and a stolen firearm was recovered from the vehicle.

On June 5, 2024, troopers observed an occupied vehicle with an IVC violation that was parked near an abandoned house. Troopers approached the vehicle and observed evidence of criminal activity. One person was taken into custody and a loaded firearm with a machine gun conversion device, as well as an extended magazine, were recovered.

Nearly 40 officers from around the state, including ISP Troops 2, 6, 7, 8, 10, ISP South Fatal Four Team, ISP Division of Criminal Investigation Zone 6, ISP Public Safety Enforcement Group, ISP Air Operations, and the Metropolitan Enforcement Group of Southwestern Illinois, joined forces with the ISP Special Operation Group Statewide Anti-Violence Enforcement South Unit for the multi-day operation. The ISP Firearms Investigations Unit, the Bureau of Alcohol, Tobacco, and Firearms, and the Madison and St. Clair County State's Attorneys' Offices provided additional support during the operational period.

ISP will continue to use all available resources including air operations, forensic services, investigators, increase patrols and information sharing to combat violent crime.

ISP Celebrates Youth Camp Success Stories

SPRINGFIELD – The Illinois State Police (ISP) is preparing for the 2024 Team Illinois Youth Police Camp (TIYPC) summer camp series across the state. The TIYPCs are highly structured week-long residency camps held in Elsah, Romeoville, and Carbondale each year. The camps are based upon a military model and are geared for teenagers between the ages of 13 and 17. Attendees, or Cadets, learn military drills and participate in physical fitness exercises. Cadets also attend classroom instruction on leadership development, substance abuse resistance, team building principles, and other life enhancing skills. TIYPCs promote positive rapport and interactions between law enforcement and the attendees. Graduates of the youth camps have experienced great success, and many have credited their camp experiences as pivotal points in reaching their future goals.

The first TIYPC originated in 2006 in the Metro East and was held in Granite City. In 2009, the location of the camp was moved to Alton, and then in 2013 it was moved to its current location, Principia College in Elsah. Since its inception, 879 cadets have graduated from the Metro East TIYPC. The 2024 Metro East TIYPC will start in July and applications for the camp are being accepted through June 14. “The ISP youth camp definitely influenced my future, because at the age of 8-years-old, I knew that I wanted to become a police officer or join the US Army,” said Swansea Police Officer and Metro East TIYPC graduate Marquis Jones. “With the help of the camp and counselors, I was able to do both. I have been a police officer for eight years and I have been serving for 13 years as a Military Police Noncommissioned Officer in the Illinois Army National Guard. After completion of the TIYPC, I was able to keep in contact with the troopers for mentoring and advice along my

journey to becoming a police officer.”

After many years of successful participation from teens across the state who attended the Metro East TIYPC, there was a desire to expand the program to help youth in other areas of the state succeed. ISP started a second camp for teenagers in the northern portion of the state. The Northern TIYPC was originally held at Olivet Nazarene University, but Lewis University in Romeoville is the camp’s current home.

“In 2017, I went to the TIYPC at the age of 14,” said Metro East TIYPC graduate MacKenzie McGee. “At that time in life, I was struggling with a lot of things. The path that I was on was going to get me in a lot of trouble, so I went to the camp. This camp impacted the way I saw my future. This camp taught me structure and discipline and from learning these things and more, I ended up choosing the military as my career. I left for the marine corps at 18 on November 15, 2021. When I look back at it, honestly, if it wasn’t for the camp teaching me these things and turning my life around, I wouldn’t be where I am today. I recently got out of the military but my next goal in life is to become a cop. I want to be able to help kids and see them succeed in life. This camp helped inspire me to be who I am today.”

In 2023, ISP, in partnership with the Carbondale Police Department, established the Southern TIYPC located at Southern Illinois University, building on the success of the other camps and

a smile on his face, he stands a little taller and his confidence has made so many gains. The best part about the camp is Gary has connected with so many positive mentors that have stayed in contact with him all year long. He has developed lifelong relationships with these local law enforcement officers and ISP Troopers."

providing a safe, structured environment where teens develop positive self-esteem and leadership skills.

"I cannot advocate enough for the TIYPC-C," stated Rene Voss, mother of Sothern TIYPC graduate Gary Stone. "It made so many positive changes in my son. He came home with self-respect, and I feel it gave him a strong sense of direction for his future. When he talks about his experience at the camp, he always gets

K9 Ride Along


That new starting salary is so good that even K-9's are volunteering to join.

ISP Makes Arrests for Road Rage Related Shooting on I-57

CHICAGO – The Illinois State Police (ISP) Division of Criminal Investigation Zone 1 arrested 25-year-old Tayvon Green-Powe of Harvey, IL for two counts of Attempted Murder (Class X Felony), stemming from a recent road rage shooting incident. ISP also arrested 25-year-old Kraig Payne of Chicago, IL for Aggravated Fleeing to Elude (Class 4 Felony) and three counts of Aggravated Unlawful Use of a Weapon (Class 4 Felony) for his part in the incident.

On June 3, 2024, at approximately 10:07 p.m., ISP Troop 3 responded to the report of shots fired on Interstate 57 northbound south of 111th Street. Upon arrival, officers learned that a red Chevrolet Impala had rear-ended a Toyota RAV-4 and both vehicles had pulled over. The driver of the Toyota then exited their vehicle and was

shot at multiple times by the driver of the Chevrolet. The Chevrolet fled the scene before officers arrived. The driver of the Toyota was transported to an area hospital with injuries.

On June 4, 2024, ISP officers located the Chevrolet, as well as Green-Powe and Payne, at an address in Harvey, IL, where they were taken into custody. ISP officers located multiple firearms in Payne's Possession at the time of his arrest. After an extensive investigation, Green-Powe was identified as the shooter.

On June 5, 2024, the Cook County State's Attorney's Office approved the above-mentioned charges and Payne and Green-Powe were transported to the Riverdale Police Department pending their first court appearance. There is no further information.

Troop 5 Releases Results of North Central Regional Fatal 4 Detail

During June 5-7, 2024, the North Central Regional Fatal 4 Detail was conducted in Troop 5. Through high volume and focused traffic enforcement, the detail focused on high traffic areas, areas with high fatal crash rates and roadways with excessive Fatal 4 violation occurrences. Over the 3-day detail, 2 platoons patrolled Dewitt, Kankakee, Livingston and McLean Counties.

Troopers from Troop 3, Troop 5, SOG North Fatal 4, SOG Central Fatal 4 and SOG South Fatal 4 participated in the detail. The following is the activity from the hard work done by all.

First New F-150 Police Responder Presented to Trooper Javier Lofton

Implementing a new squad car into the fleet can be considered the introduction of new technology, especially if the new vehicle includes advanced technological features that were not present in the previous models.

DOP will be introducing 5 brand new 2024 Ford F-150 Police Responders to their fleet in June. As the first pursuit-rated pickup truck and one of Ford's fastest vehicles in its entire lineup, the F-150 Police Responder is engineered to meet a wide range of law enforcement agency needs. This new squad car incorporates new innovations into DOPs fleet, and it represents a technological upgrade for the ISP fleet in 2024.

On June 5, 2024, Colonel Owen presented the first F-150 to Trooper Javier Lofton #7378 in Troop 6. Trooper Lofton's unwavering dedication to serve the people of Illinois is reflected

through his consistent enforcement activity, his criminal arrests, his dedication to removing impaired drivers from our roadways, team mentality, and his willingness to mentor other officers is to be commended.

Trooper Lofton was a prior Adams County Deputy (9 years) and is assigned to the Troop 6 Special Enforcement Team. Trooper Lofton volunteered for "Special Enforcement" details in Chicago and the Metro East, resulting in criminal arrests. Trooper Lofton is a Crowd Control Team member, Field Training Officer, Rapid Deployment instructor, 2023 Career Development Program participant, and serves on the Illinois Juvenile Officer Association Board of Directors.




ISP Arrests Two From East St. Louis for Murder

EAST ST. LOUIS – An Illinois State Police (ISP) Division of Criminal Investigation Public Safety Enforcement Group investigation leads to 35-year-old Cierra Whitley of East St. Louis, IL and a 15-year-old male of East St. Louis, IL, both being charged with two counts each of First-Degree Murder (Class M Felony).

On August 12, 2023, ISP agents were requested by the East St. Louis Police Department to assist with a homicide investigation that occurred in the 1700 block of Ridge Avenue. The victim, 64-year-old Anthony Jackson of O’Fallon, IL, had been located in a vacant lot with multiple gunshot wounds. While agents were investigating Jackson’s homicide, they were notified of another deceased male. The body of 74-year-old Willie Wallace of Swansea, IL was located with multiple gunshot wounds in the 700 block of N. 55th Street. Assisted by the East St. Louis Police Department, their investigation revealed the two homicides were connected.

On March 15, 2024, the St. Clair County State’s Attorney’s Office charged Whitley and filed a juvenile petition charging the 15-year-old male on the above charges. Whitley was already in custody on unrelated charges. On June 5, 2024, the 15-year-old male was taken into custody and is being detained at the St. Clair County Juvenile Detention Center. No further information is available.



Trooper Chong Soo Lim

End of Watch: June 6, 1995

Trooper Chong Soo Lim was killed when his patrol car was struck from behind while on a traffic stop on the Northwest Tollway.

His squad car was rear-ended and burst into flames. He was sitting in his squad car when a pickup truck struck the rear of his vehicle and forced it into the automobile in front of him. The force of the collision caused the gas tank to explode and trapped Trooper Lim inside. The driver of the pickup truck was arrested for DUI and later charged with manslaughter for Trooper Lim's death and sentenced to eight years in prison.

Born in South Korea, Trooper Lim patrolled District 3 in Chicago (now Troop 3) upon his graduation from the Academy. He transferred to the midnight shift in District 15, Oak Brook, just one month before his death. He is survived by his wife.

ISP Announces Results of Violent Crime Suppression in Chicagoland

CHICAGO – The Illinois State Police (ISP) conducted a violent crime suppression detail on June 5-9, 2024, in Cook County, focusing its efforts on areas which have experienced high concentrations of firearm violence; Dan Ryan, Bishop Ford, I-57 and I-290 expressways. The operation utilized intelligence and technology, aerial surveillance and inter-agency communications/collaboration to direct high visibility and intensive enforcement.

There were several notable arrests made during the detail.

On June 5, 2024, troopers with the assistance of air support located a stolen vehicle. A traffic stop was initiated, and the vehicle fled. The vehicle was located, and two suspects were arrested.

On June 5, 2024, troopers made a traffic stop on a vehicle for an IVC violation. A probable cause search was conducted, and a loaded firearm with a high-capacity magazine was recovered.

On June 6, 2024, troopers with the assistance of air support located a stolen vehicle. A traffic stop was initiated, and the vehicle fled. The vehicle was located, and three suspects were arrested.

On June 8, 2024, troopers made a traffic stop on a vehicle for an IVC violation. A probable cause search was conducted, and a firearm was recovered.

Nearly 40 officers from ISP Troop 3, ISP Division of Criminal Investigation Zone 1 Violent Crimes Unit, ISP Air Operations, Chicago Police Department, and South Holland Police Department joined forces with the ISP Special Operations Group Statewide Anti-Violence Enforcement North Unit for the multi-day operation. The Cook County State's Attorneys' Office provided additional support during the operational period.

ISP will continue to use all available resources including air operations, forensic services, investigators, increase patrols and information sharing to combat violent crime.

STIC Lt. Douglas Pool Graduates from FBI National Academy

QUANTICO, VA- Two-hundred and one law enforcement officers graduated June 6, 2024, from the FBI National Academy in Quantico, Virginia. The 290th session of the National Academy consisted of men and women from 46 states and the District of Columbia. The class included members of law enforcement agencies from 24 countries, five military organizations, and six federal civilian organizations. Lieutenant Douglas Pool, Division of Criminal Investigation and Statewide Terrorism & Intelligence Center (STIC) Center Chief, was among the 201 graduates.

Internationally known for its academic excellence, the National Academy offers 10 weeks of advanced communication, leadership, and fitness training. Participants must have proven records as professionals within their agencies to attend. On average, these officers have 21 years of law enforcement experience and usually return to their agencies to serve in executive-level positions.

FBI Academy instructors, special agents, and other staff with advanced degrees provide the training; many instructors are recognized internationally in


their fields. Since 1972, National Academy students have been able to earn undergraduate and graduate credits from the University of Virginia, which accredits all the National Academy courses offered.


